

## AVRUPA OTOYOLU YATIRIM VE İŞLETME A.Ş.

### INFORMATION APPLICATION FORM

As **AVRUPA OTOYOLU YATIRIM VE İŞLETME A.Ş.** ("Company"), the protection of fundamental rights and freedoms being in the first place; protection of privacy related to private life, ensuring and protecting information security and respect to ethical values are among our primary principles. Article 11 of the Law No. 6698 on the Protection of Personal Data ("LPPD") entitled "Rights of the Related Person" gives data owners the right to make certain requests regarding the processing of their personal data. Our company, as the Data Controller, has prepared this information application form in order to ensure that the Relevant Persons use these rights and in order to fulfil the clarification obligation stated in Article 10 of LPPD.

Pursuant to Article 11 of LPPD, you may use your rights by applying to the Company and by filling the attached form:

- a) You may learn whether your personal data has been processed or not,
- b) If your personal data has been processed you may request information related to this,
- c) You may learn the purpose of processing your personal data and whether they are used in accordance with their,
- d) You may learn the people to whom personal data have been transferred domestically or abroad,
- e) You may request correction of your personal data if your personal data has been incompletely or incorrectly processed,
- f) You may request deletion or destruction of your personal data within the frame of terms stimulated in Article 7 of LPPD.
- g) **You may request the notification of the transaction made in accordance with (e) and (f) articles to third parties to whom the personal data has been transferred.**
- h) You may object to the emergence of a result against yourself by analysing the processed data exclusively through automated systems and
- i) You may request the indemnification of your loss, in case you suffer a loss due to processing of your personal data in violation of LPPD.

Pursuant to Article 13 of the LPPD, data owners should submit their requests to our Company in written, or in other ways as will be determined by the Personal Data Protection Board ("Board"). Within this context, the applications to be made to our Company can be sent to us free of charge, by printing out this form after filling it and by selecting one of the three methods below.

It is not possible for third parties to exercise the right to receive information regulated in Article 11 of LPPD, on behalf of data owners. In order to make a request regarding personal data related to a person other than the data owner, the wet signed and notarized original of the special power of attorney, which has been issued by the data owner on behalf of the applicant person, must be submitted.

Pursuant to Article 13/2 of LPPD, your applications sent to us will be answered, according to the nature of the request, within thirty days as of the date your request reaches to our Company.
