- d) You may learn the people to whom personal data have been transferred domestically or abroad,
- e) You may request correction of your personal data if your personal data has been incompletely or incorrectly processed,
- f) You may request deletion or destruction of your personal data within the frame of terms stimulated in Article 7 of LPPD.
- g) You may request the notification of the transaction made in accordance with (e) and (f) articles to third parties to whom the personal data has been transferred.
- h) You may object to the emergence of a result against yourself by analysing the processed data exclusively through automated systems and
- i) You may request the indemnification of your loss, in case you suffer a loss due to processing of your personal data in violation of LPPD.

Pursuant to Article 13 of the LPPD, data owners should submit their requests to our Company in written, or in other ways as will be determined by the Personal Data Protection Board ("**Board**"). Within this context, the applications to be made to our Company can be sent to us free of charge, by printing out this form after filling it and by selecting one of the three methods below.
